As such, Faust was involved mainly with the drafting of new legislation pertaining to mental illness. In addition, this series contains files dealing with the Constitutional Convention of 1967, the Joint Legislative Committee on Mental and Physical Handicaps, discharges and conditional releases of patients in mental health facilities, community services, and state aid programs. Finally, there are transcripts, subject files, and legal records pertaining to a criminal trial which was eventually appealed to the Court of Appeals.
