Both approved resolutions, signed by the Commission's Secretary or Executive Director of the Department of Civil Service and by the Governor, and unsigned, disapproved resolutions

are included in the series. Occasionally a letter or memorandum relating to a resolution is also included. Resolutions contain the texts of proposed amendments to rules and regulations, the date they were passed and, if approved, the date they were signed. Amendments relate to jurisdictional classification of positions, Civil Service policy matters (e.g. terms of eligibility lists, temporary appointments), and personnel policy (e.g. attendance rules).
