This series is comprised primarily of correspondence between Office of Physical Fitness Director Hiram A. Jones and staff members or other individuals and organizations that reveals Jones's actions in directing the daily routines of the office and its programs.

This series includes: letters from schools and other organizations interested in physical fitness to which Jones usually directed others to respond. These letters typically requested pamphlets, information, or clarification regarding programs, or gave thanks for program assistance; records revealing weekly schedules of the field representatives, including name, week, each day's
