Scope and Content Note

Microfilmed records include building permits (1964-1989) including applications, plans, specifications, inactive permits, and certificates of occupancy; payroll records (1960-1984) showing each employee's gross, net, and base pay, social security tax, and federal and state withholdings; common council index (1912-1989) consisting of cards indicating action at meetings such as resolutions passed, local laws enacted, and motions made;

property record cards (1957-1974) showing ownership, address, assessed property value, sales information building record, and dwelling and data computations; assessment rolls (1973-1988) showing ownership, address, lot size, section, block and lot, assessed value and exemptions;

band tax assessment rolls (1885-1985) for city, school, county, water, and light taxes including name, address, property value, section, lot, block numbers, and amount of tax due.

Custodial History

This microfilm was produced by a grant awarded and administered by SARA's Local Government Records Services for the 1994 grant cycle. Grantees submitted two copies of each roll of project film: a silver copy for secure storage at the State Records Center; and a duplicate copy, containing only non-restricted records, for public use at the State Archives research room.

Use copies of rolls containing restricted records are not maintained by the Archives, and are withdrawn from public use at time of accessioning. Security copies of such rolls are held at the State Records Center and are subject to restrictions under law.

Restricted film was marked and use copies were weeded at time of accession; 183 rolls of master negatives (security copy) were sent to the State Records Center (TL 95-59, 60).
