This series consists of one ledger prepared by the Comptroller's Office to record United States Deposit Fund mortgage payments for the 1934-1935 fiscal year. Information is in columnar form, and each entry includes mortgage number; name of original mortgagor; date; unpaid principal; name and address of present owner; and dates payments were made on principal and interest. Some of the mortgages date to the 1860s. Some of the payments recorded date to 1938.
