The commission, which consisted of fifteen members appointed by the governor, was charged with studying the structure and operations of New York local government; reducing costs and improving the effectiveness of local government operations; and reforming election laws and procedures. The commission issued its final report, entitled "21st Century Local Government," in April 2008.
