The Erie County Fiscal Stability Authority was established in 2005 (Ch. 182, Laws of 2005) to oversee Erie County's budget, financial and capital plans, and to issue bonds, notes or other obligations needed to achieve budgetary savings.

Scope and Content Note

This series consists of archival copies of the publicly accessible website of the Erie County Fiscal Stability Authority.

B2091-07: This accretion consists of a copy of the Erie County Fiscal Stability Authority site produced on December 31, 2006, shortly before Governor George E. Pataki (1995-2006) left office. It contains information about the authority's mission and organizational structure, press releases (2005-2006), financial planning and budget reports (2005-2006), and meeting minutes and resolutions (2005-2006).

B2091-08: This accretion consists of a copy of the Erie County Fiscal Stability Authority site produced on May 7, 2008, shortly after the resignation of Governor Eliot L. Spitzer (2007-2008). It contains information about the authority's mission and organizational structure, press releases (2007), annual reports (2006-2007), strategic and financial planning reports

(2005-2007), presentations on financial planning (2007), guidelines on procurement, investment, and property disposal (2007), and meeting minutes and resolutions (2005-2008).

B2091-11: This accretion consists of a copy of the Erie County Fiscal Stability Authority Web site produced on January 4, 2011, shortly after Governor David A. Paterson (2008-2010) left office. It contains additional press releases (2007-2009), annual reports (2006-2008), strategic and financial planning reports (2009), and budgets and financial plans (2005-2011). It also includes procurement, investment, and property disposal guidelines (2008-2009), meeting minutes and resolutions (2005-2010), and efficiency grant materials.

B2091-17: This accretion consists of a copy of the Erie County Fiscal Stability Authority site produced on January 26, 2017. It contains information about the authority's mission and organizational structure, the establishing legislation, bylaws, and policies governing its operations, audited financial statements (2005-2015), and adopted budgets (2006-2020). Also present are additional minutes of meetings of the authority's Board of Directors (2005-2017), Finance Committee (2006-2016), Audit Committee (2006-2013), and Governance Committee (2006). Annual reports (2014-2015), a strategic plan (2016), reviews of Erie County and Erie County Community College budgets and financial plans (2011-2017), and efficiency grants program materials are also included.

Researchers should note that the navigational links on the left side of this site may sometimes redirect to the corresponding page in the January 4, 2011 copy of the site. To reduce the risk of redirection, do not attempt to navigate directly from one section of the site to another; instead, use the browser's Back button to return to the home page after viewing a given section or document and then selecting the next desired section on the navigational menu.

B2091-20: This accretion consists of a copy of the Erie County Fiscal Stability site produced on February 12, 2020. It contains information about the authority's mission and organizational structure, the establishing legislation, bylaws, and policies governing its operations, audited financial statements (2005-2018), and adopted budgets (2006-2023). Also present are minutes of meetings of the authority's Board of Directors (2005-2019), Finance Committee (2006-2018), Audit Committee (2006-2016), and Governance Committee (2006). Annual reports (2014-2018), a strategic plan (2016), reviews of Erie County and Erie County Community College budgets and financial plans (2011-2019), and efficiency grants program materials are also included.
