B2162-08: This accretion consists of a copy of the Rochester-Genesee Regional Transportation Authority site produced on June 7, 2008, shortly after the resignation of Governor Eliot L. Spitzer (2007-2008). It contains information about the authority's history, mission, and organizational structure; service alerts (2007-2008); and information about purchasing bus passes.
