Scope and Content Note

This series consists of archival copies of the publicly accessible website of the New York State Education Department's Office of the Counsel. Researchers should note that this site was not captured in 2014 or 2015.

B2167-07: This accretion consists of a copy of the Office of the Counsel site produced on March 13, 2007, shortly after Governor George E. Pataki (1995-2006) left office. It contains decisions of the Commissioner of Education (1991-2007) concerning a wide array of matters, information about appealing a commissioner's decision, and appeal forms, including those for appeals involving homeless youth (2005). It also includes information and forms associated with the chartering of education corporations such as schools and museums. Also present are summaries of changes to educational laws (2006) and guidance documents (2000-2005) about issues such as computer technology in schools, complying with the Individuals With Disabilities Education Act, and solicitation of charitable donations from school children.

B2167-08: This accretion consists of a copy of the Office of the Counsel site produced on May 11, 2008, shortly after the resignation of Governor Eliot L. Spitzer (2007-2008). Most of the information in this copy is also included in the March 13, 2007 copy, but this copy contains additional decisions of the Commissioner of Education (1991-2008).

B2167-11: This accretion consists of a copy of the Office of the Counsel site produced on January 14, 2011, shortly after Governor David A. Paterson (2008-2010) left office. It contains additional decisions of the Commissioner of Education (1991-2011), newer summaries

of recent changes to educational laws (2008-2011), and additional guidance documents (2000-2010) about education-related issues.

B2167-20: This accretion consists of a copy of the Office of the Counsel site produced on March 24, 2020, during the third term of Governor Andrew M. Cuomo (2011-2021). It contains additional decisions of the Commissioner of Education (1991-2020) and updated rules and regulations (2017).
