It contains background information about the corporation and newer financial plans (2017-2022), budget requests (2018-2020), and financial reports (2015-2018). Also included are reports (2016-2018) relating to the corporation's operations and performance, investments, procurement contracts, prompt payments, internal controls, and debts.
